NOTICE – IILF CHENNAI 2026 – BOOKING OF SPACE BY INDIAN AND OVERSEAS COMPANIES

India Trade Promotion Organisation (ITPO) will be organizing the 39th **India International Leather Fair (IILF)** at Chennai Trade Centre from February 01- 03, 2026.

2. The booking of space by **Indian private companies** for participation in the exhibition will be through ITPO's online booking portal <https://booking.indiatradefair.com> on **first-come, first-served basis**. Interested exhibitors will be required to complete the mandatory registration process through the portal. The link for online registration is also available on ITPO's online space booking portal <https://booking.indiatradefair.com>

3. ITPO will be opening the **First Phase** of space booking for registered Indian Companies (private exhibitors) for larger **booths of size 70 sqm and above at 12.00 Noon on November 28, 2025 (Friday). Bookings will open on first-come, first-served basis** through online booking portal <https://booking.indiatradefair.com>

4. In the first phase of booking for larger booths (70 sqm and above), registered Indian applicants will be allowed to select their booths online. Companies that successfully complete their booth selection process will be required to pay 100% of the due amount through Online payment gateway (Netbanking/Credit/Debit Card) in one go during the booking or through the **Challan** generated online through payment gateway latest by **6.00 PM on December 05, 2025**. Payment should be received by ITPO by the said date and time. Each company will be allowed to **select a maximum of 02 booths**. The **Challan payment** option will be available in the Online Payment gateway at the time of booking. Direct transfer of payment into ITPO's account without Challan will not be accepted.

5. In case any applicant fails to remit the payment by **6.00 PM on December 05, 2025**, the booth may also be released for online booking by other exhibitors. After making payment through Challan, applicants are requested to upload copies of Challan payment receipt to their dashboards. The steps to book the stall, upload challan etc. are given in the '**User Manual for IILF Chennai 2026 Registration and Online Booking**' available on the website and booking portal.

6. Second Phase (for booths under 70 sqm) of bookings for smaller booths will open soon afterwards and the exact date and time for the same will be announced on or after December 05, 2025.

7. Exhibitors interested in participating in IILF Chennai 2026 will be required to comply with the terms and conditions, rules and regulations, exhibitor manual, notices, etc. issued from time-to-time. The Hall Layouts and User Manual for registration and stall booking are available on the website and booking portal.
